Mayor Pro-Tempore Bermel opened the regular City Council meeting at 7:01 p.m.

Backous made a motion to approve the consent agenda, seconded by Brandt. All Ayes.

Granger Women's Club member Rose Dory mentioned that there will be a food donation at the United Methodist Church from 9 a.m. to Noon on September 30th.

City Engineer Report –Birch Street Alternatives Discussion – the City Council would like the City Engineer to bring back some concept plans and prices for widening Birch Street. Final Landing at Oxley Creek West Plat 2 – Resolution 2023-35 – approving the Final Plat of Landing at Oxley Creek West Plat 2 subject to releasing plat due to payment of water and sewer hook-up fees was approved by Brandt, seconded by Backous. All Ayes. New Urban Renewal Areas – Granger Urban Renewal Plan – Resolution 2023-31 – setting September 22nd for the consultation and a public hearing for October 12th on the proposed Amendment No. 5 to the Granger Urban Renewal Plan in the City of Granger, State of Iowa was approved by Brandt, seconded by Backous. – Resolution 2023-32 – determining the necessity and setting September 22nd for the consultation and a public hearing for October 12th on the proposed Southeast Urban Renewal Plan for a proposed Urban Renewal Area in the City of Granger, State of Iowa was approved by Brandt, seconded by Backous. All Ayes. Oak Street Urban Renewal Plan – Resolution 2023-33 – determining the necessity and setting September 22nd for the consultation and a public hearing on the proposed Oak Street Urban Renewal Plan for a proposed Urban Renewal Area in the City of Granger, State of Iowa was approved by Brandt, seconded by Danilson. All Ayes. The City Administrator will be attending the consultation meeting on September 22nd.

City Administrator Report – Discussion on Code Enforcement Proposal for the City of Granger not to exceed \$500 per month. The proposed Public Safety Building Project schedule is as follows: Approval to go out for bids at the October 12th Council meeting, Opening of Bids on November 7th at 2 p.m., and Public Hearing and Award of Contract at the November 9th Council meeting. Begin construction in the Spring 2024 and completion by early 2025.

Plan and Zoning Report – Action to approve Ordinance 416 regarding Storage Limitations in the C-3 District, third reading was approved by Danilson, and seconded by Brandt. All Ayes. MADD, LLC, Lamberts Landing concept plan – would like comments and general direction from the City Council on the concept plan. Harmeyer Property concept plan – the City Council would like to see 28-foot streets for commercial districts. Action to approve the public hearing for October 12th on Ordinance 418 Parkland Dedication, first reading was approved by Brandt, seconded by Danilson. All Ayes.

Police Report – The Police had 71 calls in August: 4 911 hangups, 1 alarm, 3 animal complaints, 3 domestic, 1 fireworks, 3 follow-up investigations, 1 illegal burn, 6 medical/ambulance trips, 2 meet complaints, 4 motorist assists, 3 motor vehicle PDs, 2 ordinance violations, 1 public assist, 2 return phone calls, 1 suspicious, 1 theft, 1 traffic complaint, 24 traffic stops, 1 transport, 1 vehicle fire, 2 vehicle unlocks, 2 welfare checks, and 2 fire alarms.

Public Works Report – Action to approve Ordinance 419 regarding provisions pertaining to water service discontinued, first reading was approved by Backous, seconded by Brandt. All Ayes. Brandt made a motion to waive the second and third readings, seconded by Danilson. All Ayes. Action to approve Ordinance 417 – revising requirement for backflow preventors on irrigation meters, second reading was approved by Brandt, seconded by Backous. All Ayes. Brandt made a motion to waive the third reading, seconded by Danilson. All Ayes.

Granger Days Report – The Granger Days Festival raised over \$12,000. The committee would like to spend some of the funds on a new commercial refrigerator and freezer. The City Clerk will bring back quotes for the next City Council meeting for discussion.

Action to approve Resolution 2023-34 – adopting Amendment to FY 2023-2024 Granger City Budget was approved by Brandt, seconded by Danilson. All Ayes.

Discussion of potential litigation that might involve the City – Action to hold a closed session to discuss strategy with counsel in matters where litigation is imminent where its disclosure would be likely to prejudice or disadvantage the position of the City in that litigation, pursuant to Iowa Code Section 21.5(1)(c) [requires the public vote of either two-thirds of the whole Council, or all of the members present] was approved by Brandt to include City Council, City Administrator, City Clerk, City Attorney, seconded by Danilson. All Ayes. Action to rise from the closed session at 8:43 p.m. was approved by Brandt, seconded by Backous. All Ayes.

Discussion of possible Real Estate Purchase – Action to hold a closed session by two-thirds vote of City Council members present pursuant to Iowa Code Section 21.5(1)(j) to discuss the purchase of particular real estate where premature disclosure could be reasonable expected to increase the price the governmental body would have to pay for the property was approved by Brandt to include City Council, City Administrator, City Clerk, City Attorney, seconded by Danilson. All Ayes. Action to rise from the closed session at 9:20 p.m. was approved by Brandt, seconded by Danilson. All Ayes.

Finance Committee member Backous reported that everything is in order. Action to approve the Finance Committee Report was approved by Brandt and seconded by Bermel. All Ayes.

Action to approve the bills for payment was approved by Brandt and seconded by Danilson. All Ayes.
