Rental Policies – Shelter rentals reserves the shelter only; the park will remain open to the public. Vehicles are allowed in parking lots only. No vehicles are allowed on grass areas. Rental facilities are located in public parks; therefore, all parking is first-come, first-served and cannot be reserved. Temporary structures such as tents, awnings, canopies, dunk tanks, bounce houses and other inflatable/apparatus including but not limited to those that use water or have water features are prohibited in City Parks. Disturbing the peace through excessive, loud or unusual noise is prohibited. Complaints regarding noise or other disturbances will be turned over to the Police Department. Renter's initials:			
COVID-19 WAIVER OF LIABILITY: - The City of Granger cannot prevent you or your guests from becoming exposed to, contracting, or spreading COVID-19 while utilizing the City of Granger's facilities.
