



## ALCOHOL RESPONSIBILITY AGREEMENT

For possession, consumption, dispensing of alcohol, beer and wine in City of Granger Parks and Recreation facilities

\*Consumption of alcohol is not allowed until your designated alcohol dispensing time.

Area of service of alcohol, beer and wine is confined to the rental space as defined on Agreement Use.

We, the undersigned, being of 21 years of age or older, and desiring to entertain ourselves and our guests at the above indicated facility, understand and agree to the following requirements of compliance and individual responsibility involved in the issuance of this permit.

1. Agree to assure compliance with all local, state and federal laws and local ordinances.
2. Further, I understand and agree to assure compliance with the responsibilities of a Private Social Host in a Public Place as set forth in sections 123.49 and 123.95 of the Alcoholic Beverage Control of the Iowa Codes as follows:
  - a) A host shall not solicit or accept donation, charge admission fees, ticket sales or other kinds of entrance fees for payment for food or alcoholic beverages and food and beverages shall be served without cost to the invited guests.
  - b) A host shall not sell, dispense or give alcoholic liquors. Alcohol, Wine and beer in cans or kegs are only allowed. NO GLASS BEER BOTTLES ARE ALLOWED ON THE PREMISES.
  - c) A host shall not sell, dispense, or give to an intoxicated person or one simulating intoxication.
  - d) A host shall not sell, give, or otherwise supply any wine or beer to any person, under legal age to consume wine or beer.
  - e) A host shall not dispense alcohol, wine or beer on the premises or permit its consumption after expiration of your rental contract.
  - f) A host shall not have a person under the age of 18 years of age involved in serving alcohol, beer or wine.
  - g) A host shall not allow any person outside the building with alcohol, beer or wine.
  - h) A host shall not keep on the premises any alcoholic beverage in any container except the original package purchased or reuse any container originally used for package of any alcoholic beverage.
3. The City of Granger reserves the right to require security at the event. If required, an extra charge of \$40/hour will apply. Checks will be made payable to the officer and shall be paid prior to picking up the key for the rental. You will be notified at least 30 days prior to your rental if security is required. For events of more than 100 people, a second security office may be required. For all events involving alcohol, the Granger Police may make periodic facility inspections.
4. Further, the undersigned, being of legal age and in consideration of the opportunity to use certain facilities of the City of Granger Parks and Recreation Department, and to participate in the activity identified above, hereby agrees to assume full responsibility for any risk resulting from participation in any activity and further agrees to indemnify and hold harmless the City of Granger, its officials and officers, employees, agents and representatives, from any and all claims, causes of action, demands, and expenses of every kind, including attorney's fees, resulting from the use of the City of Granger facility.
